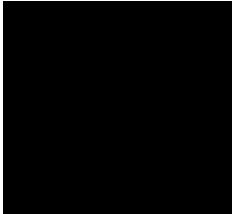

Re: Freedom of Information Request

We have received a request under the Freedom of Information Act 2015 ("the Act"), which states:-

"The current annual salary and salary scale of the Clerk to Braddan Commissioners"

Clause

While our aim is to provide information whenever possible, in this instance we are unable to provide any the information you have requested because it is absolutely exempt under section 25 of the Act (absolutely exempt personal information).

The reasons why that exemption applies are that Braddan Commissioners is satisfied that the information amounts to personal data under the Data Protection Act 2002.

Braddan Commissioners is satisfied that disclosure of the information would contravene one of the data protection principles, namely that Braddan Commissioners can only disclose the information where it would be fair, lawful and meet one of the conditions in schedule 2 or schedule 3, and in this case, none of those conditions have been met.

Your right to request a review

If you are unhappy with this response to your Freedom of Information request, you may ask us to carry out an internal review of the response, by completing a complaint form and submitting it electronically or by delivery/post to the FOI Co-ordinator, Braddan Parish Commissioners, Close Corran, Union Mills, Braddan, IM4 4LZ. Your review request should explain why you are dissatisfied with this response, and should be made as soon as practicable. We will respond as soon as the review has been concluded.

If you are not satisfied with the result of the review, you then have the right to apply for a review of decisions by the Information Commissioner, for a decision on;

1. Whether we have responded to your request for information in accordance with Part 2 of the Freedom of Information Act 2015; or
2. Whether we are justified in refusing to give you the information requested.

In response to an application for review, the Information Commissioner may, at any time, attempt to resolve a matter by negotiation, conciliation, mediation or another form of alternative dispute resolution and will have regard to any outcome of this in making any subsequent decision.
